Degree: One-Semester Technical Certificate

PHARMACY TECHNICIAN PROGRAM - 11 credits

The Pharmacy Technician (PhT) program is a one-semester program. Students must complete 11 credits to graduate. The program combines lecture, laboratory, and clinical courses. Travel is required to clinical sites; students must provide their own transportation. Clinical locations are to be determined.

ACADEMIC ADMISSION REQUIREMENTS

You will be admitted to the program based on the date and time the above admission criteria is met.

PHARMACY TECHNICIAN COURSEWORK

Most Pharm Tech courses are offered online. One evening a week on-campus provides hands-on learning experiences. BLS Basic Life Support training must be completed before students start clinical training.

CLASS COMMITMENT

In addition to scheduled class time, it is expected that students spend at least two to three hours studying for each hour of classroom lecture they attend. This represents a significant time commitment, and most students find it necessary to reduce work hours during the program.

TRANSFER CREDIT

Official college transcripts are required for any college coursework that has been completed. Official college transcripts must be sealed and sent from the sending institution.

PHARMACY TECHNICIAN PROGRAM STANDARDS

Students <u>must</u> earn a grade of 2.0 or higher in <u>all</u> required courses. This policy includes coursework taken at other colleges. Students must also successfully pass all required course competencies. For specific program course requirements, see individual course syllabi. Failure to achieve a 2.0 in a course, failure to achieve the exam score as specified in the individual course syllabi, or failure to pass all required course competencies will delay advancement in the program until an acceptable grade is achieved. Program courses may only be repeated once. If a course needs to be repeated, please contact your advisor before registering. This policy also applies to coursework taken at other colleges.

COMPUTER NEEDS

Since all PhT courses include a web-based component, students are required to have computer and internet access.

BACKGROUND CHECK AND CONVICTION RECORD

Students in the PhT program will attend clinical sessions in hospital and community pharmacies that are regulated by state and federal government. The laws state that these clinical agencies may not hire anyone with a history of conviction of certain crimes. Northwood Tech must contract with these agencies to provide your clinical experiences while in the program. In order to do so, the agencies expect Northwood Tech to adhere to the same guidelines—in other words, they view students as temporary employees.

Within 90 days of the start of PhT clinical courses, a caregiver background check will be run through the Wisconsin Department of Health Services along with a national criminal background check, and, if applicable, the Minnesota Department of Human Services. Having a conviction history will not necessarily stop you from entering the program. We will need to discuss the charges with you and will make every attempt to confidentially resolve the concern with the hospital and community pharmacies utilized for the clinical courses. Ultimately the hospital and community pharmacies reserve the right to determine what is an acceptable background check. The pharmacy may deny access to their setting based on a negative background check. If this occurs, you would not be able to complete the PhT program requirements. The costs of background checks are the responsibility of the student.

You will also be asked to comply with mandatory drug testing. Positive results on the drug test may also prevent you from being placed in a hospital or community pharmacy.

PROGRAM PROGRESSION OPTIONS

The Pharmacy Technician program is scheduled to be completed in one semester as indicated on the Curriculum Checklist.

SCHOLARSHIPS AND FINANCIAL AID

Financial aid is available to help you pay for your education. It can come in the form of grants, loans, federal work-study, military and veterans benefits, division of vocational rehabilitation benefits, and scholarships.

Students in the Pharmacy Technician program may not be eligible to receive full financial aid, due to Department of Education regulations on how credits are recognized. For more information contact your <u>campus Financial Aid Advisor</u>.

CERTIFICATION EXAM

Graduates are eligible to take the Certified Pharmacy Technician (CPhT) certification examination through the Pharmacy Technician Certification Board (PTCB).

GRADUATE SALARY EXPECTATIONS

Aggregated statewide graduate outcomes indicates average monthly salaries are between \$31,198-\$42,070 annually and the average yearly salary \$38,475.

COVID vaccination---highly recommended **NOTE:** Northwood Technical College cannot guarantee clinical placement or ability to progress in the program if a student is not able to meet the clinical site requirements including but not limited to; influenza vaccine, covid vaccine, negative tb skin test or QuantiFERON®-TB Gold In-Tube test (QFT-GIT) or T-SPOT®. TB test (T-Spot), up to date acceptable background check, or any other clinical requirements required by the clinical site. Northwood Technical College cannot guarantee clinical placement if the clinical site must be changed due to students inability to meet the site specific requirements. Many sites require the student information 4-6 weeks prior to the clinical start date.
