Sensory Skills	<ul> <li>The student must demonstrate:</li> <li>Vision sufficient for observation and assessment of patient care.</li> <li>Tactile, auditory, visual, and olfactory ability for data collection/assessment and to promote a safe care environment.</li> <li>Ability to tolerate exposure to odors and common allergens.</li> </ul>	<ul> <li>Visually identify changes in client's condition, such as pallor, cyanosis</li> <li>Perform health assessment auscultations (i.e., lung, heart, and bowel sounds, blood pressure) and identify accurate assessments</li> <li>Collect, clean, or interact with blood and body fluid of others</li> </ul>
